

Peoples Bank & Trust Co. Scholarship Guidelines

The scholarship provides up to four years of \$1,000 per semester, maximum \$2,000 per year, toward tuition and room and board to scholarship recipients to the college of their choice.

Eligibility

Only high school seniors who are a US citizen and who attend high school or is a homeschool/private school student that permanently reside in the following Missouri counties or have an account with PB&T are eligible to apply:

- Lincoln County, MO - Silex R-1, Elsberry R-2, Troy R-3, and Winfield R-4
- St. Charles County, MO - St. Dominic, Fort Zumwalt (North, South, East, and West), Christian High, and Francis Howell Central High
- Pike County, MO - Clopton High School, Louisiana R-2 and Bowling Green R-I
- Warren County, MO - Warren County R-III

Scholastic Criteria:

1. High School – minimum cumulative 2.75 grade point average
2. College – minimum cumulative 2.75 grade point average
3. If cumulative grade point average is not met, Trustee Board will enforce a scholastic probation of one semester. If cumulative 2.75 is not obtained, scholarship will be revoked.

Rules for Maintenance of Scholarship

1. Student must provide the Trustee Board with college transcript each semester for review to determine maintenance of eligibility criteria.
2. In the event the student is involved in any disciplinary action with his or her college and/or any law enforcement agency, the scholarship will be subject to review by the Trustee Board with possible revocation.
3. Room and board is limited to on campus housing. If the student chooses to live off campus, or chooses to a sorority or fraternity with higher living expenses, the scholarship will pay only the basic rate of housing for on campus living.
4. All payments will be made directly to the college that the student attends to cover tuition and housing only. The student is responsible for any additional expenses.

Incomplete scholarship applications will not be processed or considered for scholarship awards. People's Bank and Trust is Not responsible for notifying a scholarship applicant if the requirements are Not met or the scholarship application is Incomplete.
